- This form must be completed with your instructor's signature each semester that you attend NWLTC in order for you to be certified for your benefits. If you add a class, drop a class, or any changes have been made to your original schedule, you must notify the financial aid office in order to adjust your certification with the VA. Failure to do this step may result in a debt owed to the school or the VA.
- Students should review the SAP Policy located in Student Services concerning academic probation and suspension to insure that they are making satisfactory academic progress.
- The VA will not award benefits for courses that do not count toward your degree program except for developmental courses. **Developmental courses online are not approved for payment under the GI Bill by the VA.**
- NWLTC can ONLY certify courses that count toward your degree program, with the exception of those listed in the developmental course section or approved prerequisites by your academic advisor.
- Payment arrangements must be made with the business office prior to the semester starting if your benefit does not send tuition and fees directly to the campus from the VA. Please check your benefit type for its policies and procedures.
- No book vouchers will be issued to GI Bill recipients. Book vouchers will only be issued if you are receiving additional aid that qualifies you for one.
- Students eligible for Chapter 33 and VRAP must provide a Certificate of Eligibility to the School Certifying Official in the Financial Aid Office in order to certify enrollment.
